TEALING ACTIVE TRAVEL ROUTES

Following on from our local paths survey and discussions with local residents and walkers, we're pleased to report that Angus Council is commissioning an in-depth study of potential active travel routes in the village. The study is currently out to tender and the council hopes to appoint a consultant soon. The format is likely to be similar to the one recently conducted in Inchbare (available online) and local groups and residents will be involved in the consultations. The study will thoroughly determine the various path options and take a rigorous look at prioritisation and deliverability.

WHAT IS A COMMUNITY WOODLAND?

There are now hundreds of community woodlands across Scotland, many of them owned and run by local developments trusts along with groups of local volunteers. Some are the size of large forests and others are quite small spaces. Most offer a rich mix of leisure, education, health and outdoor activities such as woodland paths, picnic areas, outdoor learning for children and adults, fitness trails, wood sculptures, insect and wildlife preservation, planting and woodland management. We're starting to explore whether there is scope for developing a small community woodland in Tealing and thinking about potential sites. TCC MEETING UPDATES



We met with senior representatives of SSEN, including their lead planning officer and Head of Corporate Governance, on 15th August. This was to discuss the upcoming formal planning application for the third substation in Tealing to

be sited at Balkemback Farm and the cumulative impact of the development with associated pylons routes, battery storage facilities and solar farms in and around the area. It's fair to say that SSEN make much of their claims to be engaging with the community, with a series of consultations and the appointment of community liaison officers. In practice though, our observation is that these discussions have had zero impact on SSENs plans for our area. They refuse to make any changes to their plans despite our community challenging the site and scale of the substation. They have presented no evidence to us on why other sites identified by community members (which do not ride over the local area plan) should not be considered, and are doggedly moving forward with their proposal for the 220-acre site at Balkemback. Concerns about the impact of this on increased traffic, pollution, loss of agricultural land, flood risk and road safety have been downplayed, whilst proposed alternatives have been dismissed as too costly or at higher risk of flooding - even when our local knowledge proves that to be inaccurate.

Some residents have heard that the site will go ahead regardless of the local protests against it as it is part of the National Net Zero plans. Whilst there is a certain feeling of doom descending on the inevitability of these plans, we will advise on how you may wish to add your objections (or support them) when formal planning permission is sought later this year. We know that a pre-planning application has been submitted and that SSEN representatives are able to meet with and discuss their application with the planning officials in Angus Council. No such courtesy is extended to the community council to discuss their concerns with the same planning officials. Minutes of the August meeting are available on our Facebook page.

CHANGES TO RECYCLING

Glass will no longer be collected in the bins. All households are getting a new blue bin for paper and cardboard only, to be emptied every 4 weeks. Plastic bottles and pots, tubs and trays, and food and drinks cans and cartons will continue to go in the grey bin. Glass MUST be taken to glass recycling points. The council is increasing the number of glass recycling points from 23 to 190. The purple (non-recyclables) bin will continue to be collected every two weeks and there will be random checks on their content to be sure the new guidance is being followed.

SSEN TRANSMISSION COMMUNITY BENEFIT FUNDS UPDATE

SSEN Transmission has launched its first community benefit fund for organisations across the north of Scotland to apply for a share of £2 million for projects they hope will aid skills development, support the culture of local communities and help alleviate fuel poverty. It covers the SSEN Transmission network area and aims to fund larger-scale projects that create sustainable value for communities. Applications are open until Friday 22nd November, with a minimum funding application level of £40,000. This will be followed by local funds dedicated to communities situated close to the new infrastructure developments. For Tealing, significant funding is expected via the Kintore – Tealing 400kV Connection project. The UK Government is currently considering its guidance for close communities funding and (in response to its initial consultation) suggested £200,000 per km of overhead line. The local funds for larger new projects will be designed in partnership with communities with independent decision-making at its heart. Should the project go ahead, awards are expected to coincide with the start of main construction.
